COMPOSITION/INFORMATION ON INGREDIENTS:

Contains Sodium Metasilicate and Sodium Carbonate with wetting agents Harmful/corrosive substance to respiratory system, eyes & skin.

HAZARDS IDENTIFICATION

ACUTE EFFECTS - Harmful if swallowed, inhaled or absorbed through skin. Material is destructive to tissue and mucous membranes and upper respiratory tract, eyes and skin.

FIRST AID MEASURES

In case of contact, immediately flush eyes or skin with copious amounts of water for at least 15 minutes whilst removing contaminated clothing and shoes. Assure adequate flushing of the eyes by separating the eyelids with fingers. If inhaled, remove to fresh air. If not breathing give artificial respiration. If breathing is difficult, give Oxygen. Call a doctor. Wash contaminated clothing, discard contaminated shoes.
